ROCKINGHAM PARISH MEETING

An assembly of Rockingham Parish Meeting took place via Zoom video conferencing at 7.30pm, on Thursday, 10 December 2020.

Those in attendance were:

Apologies - These were received from Mr J Saunders Watson, Mr D Norman, Cllr S Naden-Horley.

Resignation – It was noted that Cllr R Rutt had resigned as Borough Councillor for the parish in August 2020. Because there would be elections in May 2021, there would be no by-election.

Declarations of Interest - The Chairman invited those present to make any declarations of interest: -

There were none.

2-1 MINUTES

The minutes of the meeting held on 20 August 2020, having been circulated, were taken as read. Miss C Johnson proposed, Mr J Martin seconded, and the meeting agreed that the Chairman sign them.

2-2 MATTERS ARISING

2.1 Highways – <u>Speed Indicator Sign</u> – It was noted that Corby BC were proposing to remove the Speed Indicator Sign into storage. The cost of buying our own was from £1470.

<u>Speed Limit on Hill</u> - It was suggested that the speed limit should be reduced to 40 mph between the roundabout at the trop of the hill to the village entrance.

<u>Footpath on Hill</u> - It was noted that pedestrians were walking down the roadway to socially distance which was putting themselves in danger.

<u>17 Main Street</u> – It was noted water was again pouring out of the verge and freezing in cold weather. It was agreed to report this to Street Doctor again.

2.2 Criminal Activity – The meeting noted the case was still ongoing.

2-3 FINANCE

3.1 Payment of Accounts – The meeting noted that payments had been made amounting to £460.00, as listed in the attached schedule, required retrospective approval Miss C Johnson proposed, Mr M Kingman seconded, and the meeting agreed the payments.

It was also noted that payments amounting to £14.39, as listed in the attached schedule, required approval. Miss C Johnson proposed, Mr J Martin seconded, and the meeting agreed the payments.

3.2 Precept 2021/22 - The meeting considered a schedule of estimates. Mr M Kingman proposed, Mr J Martin Johnson seconded, and the meeting agreed a precept of £3124 – an increase of 40.00% on the previous year's total which was being made in consequence of the removal of grants for concurrent services in future years. It was estimated that this would equate to a 1.22p per week increase for Band D properties.

2-4 ANY OTHER BUSINESS

- **4.1 Traveller's Site Application: Ashley Road, Middleton –** The meeting agreed that an objection should be registered against this application.
- **4.2 Dog Fouling in The Cottons/Michaels Walk** The meeting noted that this was an increasing problem and asked residents to be vigilant to identify the dog owners.
- **4.3 Parking on Verges** The meeting noted that there was a problem with residents who had off street parking not using it, parking on verges and in other lay-bys instead. It was agreed to ask King West to

contact their tenants about this. There was also a problem of parking across the footpath, and it was agreed to refer this to King West also.

4.4 Litter - It was noted that this was a particular problem on the verges between the village and the river Welland. It was agreed to contact Corby BC.

2-5 NEXT MEETING

The next parish meeting was arranged to take place on Thursday 25 March in the Village Hall.

Note – Owing to a subsequent lockdown this was rearranged as the Annual Meeting at **7.30 pm** on **Wednesday 19 May** in the **Village Hall**.

There being no further business, the Chairman thanked all for their attendance, and declared the meeting closed at 8.25 pm.
